Protective masks or other facial coverings are REQUIRED while inside county and municipal courthouses. During courtroom proceedings, the judge may require the removal of masks or face coverings for a brief period of time for the fair presentation of the case. In such instances social distancing should be observed. Persons may be required by judges, courthouse staff, or law enforcement to briefly

remove their mask when necessary for identification purposes. All persons employed in, conducting business in, or otherwise visiting or present for any reason in county and municipal courthouses statewide shall be screened for fever by courthouse staff using an infrared or temporal thermometer. Anyone who registers a temperature of 100.4 degrees Fahrenheit or above shall not be admitted. Any person who refuses to comply with these directives is subject to contempt for violation of this order. This order does not prohibit anyone from wearing other PPE, including but not limited to gloves, in addition to their mask or other facial covering. *Eff. 07/30/2020.*

SC State Appellate Courts is holding oral arguments and hearings by Cisco WebEx. Rules for service/delivery of appellate documents are modified as outlined in the Order. While order is in place, no fee for extensions of time. All due dates from 3/20/2020 through 06/08/2020 are extended 20 days, except notice to file appeal. There will be forgiveness of procedural defaults from 3/13/2020 to 03/20/2020. *Eff. 05/29/2020*

Participation in Closings of Real Estate Transactions – to the extent that the Rules of Professional Conduct may require an attorney to be physically present at the closing of a real estate transaction and in close

proximity to the parties to the transaction, an attorney may participate in and supervise the closing of a real estate transaction by way of a video conference. Necessary persons to a real estate transaction may, under the direction of the supervising attorney, similarly participate in the real estate closing by way of a video conference, provided any necessary person so consents; further, the supervising attorney shall ensure that the attestation of a recordable instrument is accomplished, which may be satisfied by use of real-time audio-visual communication technology, provided the identity of any necessary person is confirmed and a notary attests the signature of any necessary person. The supervising attorney shall consult with any lender(s) and any participating title insurance company to ensure that the real estate closing measures taken are acceptable to the applicable lender(s) and title insurance company. This order is effective as of May 1, 2020 and remains in effect until August 1, 202, unless modified or rescinded earlier. *Eff. 05/01/2020.*

United States District Court—District of South Carolina: the following person shall not enter a federal courthouse in the District of South Carolina:

1. Unvaccinated persons who have travelled internationally in the past 14 days,
2. Persons diagnosed with COVID-19 within the previous 14-days,
3. Persons who have been asked to self-quarantine by any doctor/hospital/health agency within the previous 14-days,
4. Fully vaccinated persons who have been exposed to COVID-19 and are experiencing symptoms of COVID-19,
5. Unvaccinated persons who have been exposed to COVID-19 within the previous 14-days,
6. Persons with any symptoms of COVID-19 identified by the CDC, including fever

or chills, cough,  
shortness of breath,  
fatigue, muscle or  
body aches,  
headache, new loss  
of taste or smell,  
sore throat,  
congestion or runny  
nose, nausea or  
vomiting, and  
diarrhea.
